Re: Product Shipping Document regarding Product Regulatory Compliance

Kimball does not place any goods on the market but provides manufacturing services to you. By accepting the Certificate of Compliance that incorporated this Product Shipping Document Statement regarding Product Regulatory Compliance (the “PSD Statement”), you understand and agree that you are responsible for specifying components, materials, and vendors that meet the requirements of applicable Product Content and Impact Regulations, which means applicable laws or standards restricting the use of substances in goods, the sources of substances in goods, or otherwise protecting human life or the environment related to the manufacturing of goods, which by way of nonexclusive example would include (i) “RoHS”: (EU Directives 2011/65/EU on Restriction of Hazardous Substances Directive and 2015/863 amending Annex II to Directive 2011/65/EU); (ii) “WEEE”: (EU Directive 2002/96/EC on Waste Electrical and Electronic Equipment); (iii) “REACH”: (EC Regulation No 1907/2006 on Registration, Evaluation and Authorization of Chemicals); (iv) any European Union Member State’s implementations of RoHS, WEEE and REACH; (v) “Conflict Minerals”: as defined in the U.S. Dodd-Frank Wall Street Reform and Consumer Protection Act § 1502(b) and any implementing legislation and rules thereof; (vi) “CHINA RoHS”: the People’s Republic of China (PRC) Management Methods for the Restriction of the Use of Hazardous Substances in Electrical and Electronic Goods; (vii) “UFLPA”: the U.S. Uyghur Forced Labor Prevention Act and any implementing legislation and rules thereof; and (viii) any other customer-specific standard or regime mutually agreed to in writing by Kimball; as each is amended, modified, or replaced from time to time.

Kimball Electronics does not warrant and makes no representation as to whether the goods covered by the Certificate that incorporated this PSD Statement comply with Product Content and Impact Regulations.
